SECTOR POLICING: NATIONAL INSTRUCTION 3/2009 AND IMPLEMENTATION GUIDELINES

- A.1. Find attached the approved Sector Policing National Instruction 3/2009, issued in terms of Consolidation Notice 6/2009 and the Implementation Guidelines for Sector Policing, version 01, dated 2009-09-23.
- 2. The Draft National Instruction/2003 and the Divisional Instruction on Sector Policing, reference number 3/1/5/1/342 dated 2006-12-12, are herewith revoked.

3. The SAPS incorporated Sector Policing as a focus area for normalising crime in the Strategic Plan. Sector Policing will be implemented over a three (3) year Medium Term Expenditure Framework (MTEF) period.
4. Provincial Commissioners must ensure that Sector Policing is fully implemented at all police stations in accordance with the following:
 - 4.1. The undermentioned **forty-five (45)** police stations (identified in the Auditor General's report for the financial year 2008/9): **Implemented by 30 October 2009:**

- 4.2. By **30 November 2009**, Sector Policing must be implemented at all the **169 High Contact Crime** police stations.
- 4.3. **Priority police stations**, identified by the Provincial Commissioners, by **30 June 2010**.
- 4.4. All the remaining police stations by **31 December 2012**.
5. Provincial Commissioners must identify the priority police stations and the remaining police stations (par 4.3 and 4.4 above) and submit an implementation plan with time frames for the abovementioned implementation of sector policing. The Implementation Plan, with the identified stations, must be submitted before/on 2009-11-30 to the Divisional Commissioner, Visible Policing, for attention Dir R van Staden.
6. Provincial Commissioners must provide the progress with the implementation of sector policing (in accordance with par 7.1 and 7.2 of the attached Implementation Guidelines for Sector Policing) on a quarterly basis to the Divisional Commissioner, Visible Policing.
7. Visible Policing division will visit your provinces and police stations to render the necessary assistance and support with the implementation of the abovementioned.
